A Brief History of the Starving Artist Art Show[®]

(1963-2024)

In April of 1963, Rev. R. Paul Soupiset held the first Starving Artist Art Show® on Easter Sunday. It was inspired by the "Starving Artists" of La Villita. Rev. Soupiset wanted to give young and unknown artists an opportunity to show their works and at the same time help gain funds for the year-round food program at the Little Church benefiting the poor in San Antonio. The artists donated a portion of their sales to the Little Church.

Rev. David W. Edmunds came to the Little Church as an Associate Pastor in January, 1964 and became Pastor in 1969 after the death of Rev. Soupiset. Under the direction of Rev. Edmunds' wife, Rev. Cleo Edmunds, the show was expanded in the 1970s and became one of the largest art shows in the United States registering over 1,000 artists and craftsmen for many years. In 1981 A National Registered Trademark for the Starving Artist Art Show was obtained in order to preserve the popular event for San Antonio and future generations.

The registration fees from our participating artists, both accomplished and beginners, help support the Little Church Food Program. Through the Little Church Food Program, the poorest of the poor in San Antonio have a place to go for emergency food without a waiting period or a lot of red tape. The Food Program at the Little Church has been in existence since 1957.

The Starving Artist Art Show was voted one of the top 200 art events in the United States by Sunshine Artist Magazine. Well known artist, Raul Gutierrez, got his start in our art show.

This year will be our 62nd Year!
